ARTICLES OF INCORPORATION

THE UNDERSIGNED INCORPORATOR to these Articles of incorporation is a natural person competent to contract and form a corporation under the laws of the State of Florida and does certify that Quantum Computer Resources, Inc. has become a corporation under and pursuant to the following Articles of Incorporation.

ARTICLE

The name of this corporation is Quantum Computer Resources, Inc..

ARTICLE !!

The general nature of the business to be transacted by this corporation is to engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.
