FIRST: The name of the corporation is Graphic Woodcraft, Inc.

SECOND: The period of its duration is perpetual.

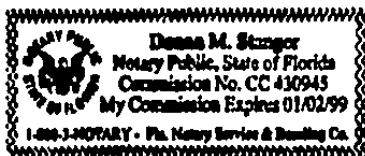
