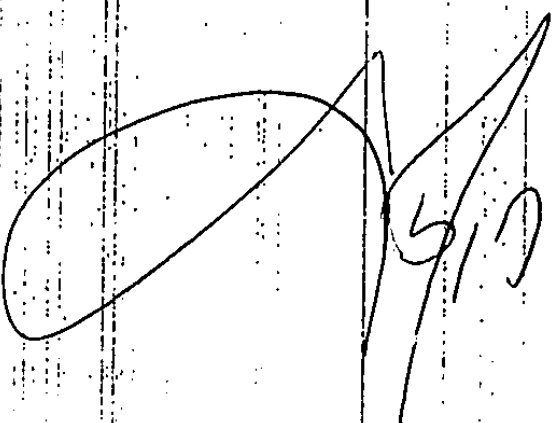

ARTICLE INAME
