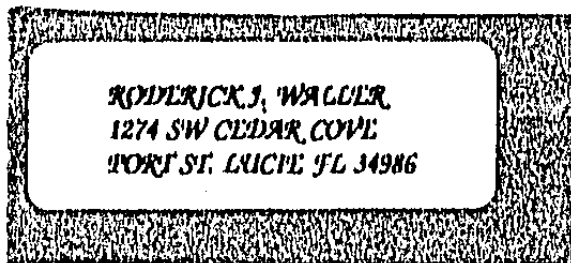

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopts the follow Articles of Incorporation for such corporation.

ARTICLE I NAME

The name of the corporation shall be TREASURE COAST TECHNOLOGIES GROUP, INC.

ARTICLE II PURPOSE

The general nature of the business to be transacted by the corporation shall be to operate a computer consultation firm, buying and selling all manner of computers; to employ such persons, firms or corporations as may be reasonably necessary to assist in the business of the corporation; and to otherwise engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III DURATION

This corporation shall have perpetual existence commencing on the date of recording of these Articles of Incorporation.

ARTICLE IV STOCK

The amount of capital stock authorized for the corporation is a maximum 1000 shares of common stock having a par value of \$3.00 per share and which shall be issued as fully paid and nonassessable. The stock of this corporation shall be so assigned, issued and transferred only in

accordance with such bylaws as the corporation shall from time to time make, change or alter with a lien reserved in favor of the corporation upon all of its capital stock for any indebtedness which may at any time be due by the holder of the same unto the company.

ARTICLE V ADDRESS

The principal place of business of said corporation is 1274 S.W. Cedar Cove Port St. Lucie, Florida 34986-0000, with the privilege of having branch offices at other places within or without the State of Florida as may be designated.

ARTICLE VI REGISTERED AGENT
