ARTICLE I - NAME

The name of this corporation is RESIDENTIAL CONSUMER SERVICES, INC.

EFFECTIVE DATE

5-9-96

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - INITIAL MAILING ADDRESS

The initial mailing address of the corporation shall be 435 Douglas Ave, #1905-C, Altamonte Springs, Fl. 32714 This address may be changed and a principal office established and/or relocated without amending these Articles of Incorporation.

ARTICLE IV - PURPOSE

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE X - PREEMPTIVE RIGHTS


