**ARTICLE I. CORPORATE NAME.**

The name of this corporation is MAZO FINANCE INTEREST GROUP, INC., and the principal place of business and mailing address of this corporation is 28100 U.S. 19 North, Suite 502, Clearwater, Florida 34621.

**ARTICLE II. DURATION.**

This corporation shall exist perpetually.

**ARTICLE III. PURPOSE.**


