ARTICLES OF INCORPORATION

OF

ARTICLE I. CORPORATE NAME.

The name of this corporation is ALL SEASONS TRADE & FINANCE, INC., and the principal place of business and mailing address of this corporation is 28100 U.S. 19 North, Suite 502, Clearwater, Florida 34621.

ARTICLE II. DURATION.

This corperation shall exist perpetually.

ARTICLE III. PURPOSE.
