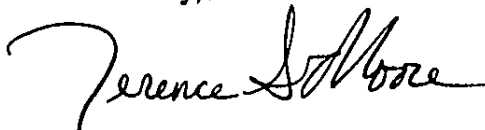

I, the undersigned, hereby present myself for the purpose of becoming a corporation under the law of the State of Florida.

FIRST: The name of the corporation is A-WAY INC..

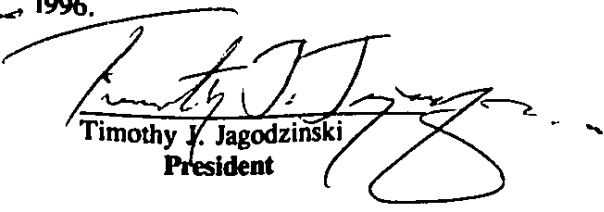
