The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is:
LEGAL RESEARCH AND LITIGATION SERVICES, INC.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles, and is to exist perpetually.

ARTICLE III: PURPOSE
