

# ARTICLES OF INCORPORATION OF CAMPAIGN INTELLIGENCE, INC.



The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

### ARTICLE 1 -- NAME

The name of the Corporation shall be Campaign Intelligence, Inc.

There shall be at any one time no more than thirty-five shareholders of the Corporation. Shareholders may be individuals, estates, or those kinds of trusts permitted to be stockholders in Subchapter S corporations by the Internal Revenue Service. Shareholders must be citizens or residents of the United States, and they may not be nonresident aliens, partnerships, or corporations.

#### ARTICLE VI -- STOCK

There shall be one class of stock of the Corporation. The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 3,500 shares.
