We, the undersigned, who hereunto subscribe, make this certificate for the purpose of forming a corporation, to be known as, **Adornment Unlimited Inc.**, associating ourselves together for the purpose of becoming such corporation for profit under the laws of the STATE OF FLORIDA for the purpose and with the rights, powers, and objects hereinafter set forth, as follows,

### ARTICLE I

The name of the corporation shall be **Adornment Unlimited Inc.**

### ARTICLE II

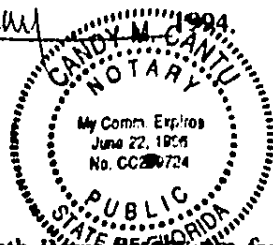
