
**ARTICLE VIII - INDEMNIFICATION**

**ARTICLE IX - AMENDMENT**



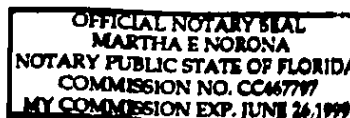
