**THE UNDERSIGNED SUBSCRIBER** to these Articles of Incorporation, a natural person, competent to contract, hereby presents these Articles for formation of a Corporation for profit under the Laws of the State of Florida.

**ARTICLE I - NAME**

**The name of the Corporation shall be:**

**ARTICLE II - PURPOSE OF THE CORPORATION**

**The general purpose for which this Corporation is organized is: to provide general construction services to the public; to buy, sell, market, rent, lease or trade legitimate goods, materials or services within the United States of America and the State of Florida; and to engage in any other legitimate business activity permitted under the Laws of the State of Florida and the Laws of the United States of America.**

**ARTICLE III - CAPITAL STOCK**

**The actual number of shares of stock that this corporation is authorized to have outstanding at any time is ten thousand (10,000) shares of common stock, each share having the par value of one United States Dollar (\$1.00) each. Authorized capital stock may be paid for in cash, services or property and at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting.**

**ARTICLE IV - INITIAL CAPITAL**

**ARTICLE V - TERM OF EXISTENCE**

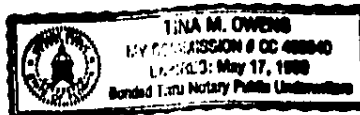
