#### ARTICLES OF INCORPORATION

OF

#### ADVANCED DOOR SYSTEMS, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is ADVANCED DOOR SYSTEMS, INC.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this State.

FOURTH: Authorized Shares.

NUMBER: The aggregate number of shares that the corporation shall have the authority to issue is 6000 shares of Capital Stock with a par value of \$1.00, per share.

INITIAL ISSUE: 100 shares of the Capital Stock with a par value of \$1.00 per share.

STATED CAPITAL: The sum of the par value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

DIVIDENDS: The holders of outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.

NO CLASSES OF STOCK: The shares of the corporation are not to be divided into classes.

NO SHARE IN SERIES: The corporation is not authorized to issue shares in series.

FIFTH: The rincipal place of business and address of the Corporation is 2730 Central Avenue, St. Petersburg, Florida 33712.

The address in Florida of the initial registered office of the

corporation is: 2730 Central Avenue, St. Petersburg, Fldrida 33712, and the name of the initial registered agent at such address is Anthony P. Valente Jr., Esquire.

SIXTH: The initial board of directors shall consist of not less than one (1) nor more than three (2) members, as set forth in the By-laws, who need not be residents of the State of Florida or shareholders at the corporation.

<u>SEYENTH:</u> The names and addresses of the persons who shall serve as directors until the first annual meeting of shareholders, or until successors have been elected and qualified as follows:

## NAME ADDRESS

Jonathan B. Benjamin 2730 Central Ave., St. Petersburg, FL EIGHTH: The name and address of the initial incorporator is: Anthony P. Valente Jr., 2730 Central Ave., St. Pete., FL 33712.

NINTH: The shareholders shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a stockholder meeting, with not less than a two-thirds vote of common stock.

TENTH: The holders of common stock of this corporation shall have the preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, such as

the shares of the stock of this corporation as may be issued for money or any property or services from time to time, in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder to all shares of common stock currently authorized and issued.

ELEVENTH: The shareholders of this corporation shall be allowed to vote their shares cumulatively so as to give che candidate as many votes as the number of directors to be elected, multiplied by the number of his shares, and to distribute them among as many candidates as he may wish. Notice must be given by any shareholder to the President or Vice President of said corporation not less than 24 hours prior to the time set for the holding of a shareholders' meeting for the election of directors that said shareholder intends to cumulate his vote at said election.
