

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be: Palmdale Fisheating Creek Campground, Inc.

ARTICLE II

Principal Place of Business and Mailing Address

The principal place of business and the mailing address of this corporation shall be: 10690 Martha Street

ARTICLE III

Purposes

The general purposes for which the corporation is organized are:

- 1. To engage in the business of operating a public, general occupancy, campground, available to the camping public at divers locations in that area of Glades County, Florida, known locally as Fisheating Creek, more particularly described in a certain lease dated November 18, 1995, by and between LYKES BROS. INC., a Florida corporation, and Oran and Martha Renfroe.
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceding business.
- 3. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.


