ARTICLES OF INCORPORATION OF

JFM TAKING CARE OF BUSINESS, INC.

STATE ALL MARK DIS

The undersigned incorporator, for the purpose of forming a corporation under the Plorida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE L. NAME

The name of the corporation ("Corporation") is JFM Taking Care of Business, Inc.

ARTICLE.IL - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III - PRINCIPAL OFFICE

The street address of the principal office of the Corporation is: 3892 Prospect Avenue, Suite 3, West Palm Beach, FL 33404.

ARTICLE IV - AUTHORIZED SHARES

Number. The maximum number of shares of capital stock which may be issued by this corporation shall be as follows: ONE THOUSAND (1,000) shares of common stock with a par value of TEN and NO/100 DOLLARS (\$10.00) per share which may be paid for in cash or property, real, personal or mixed, or labor or services at a just valuation to be fixed by the Board of Directors.

Stated Capital. The sum of the par value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

Dividends. The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.

ARTICLE IV - DURATION

The period of duration of the corporation is perpetual.

ARTICLE V - INITIAL REGISTERED AGENT

ARTICLE VI - NUMBER OF DIRECTORS

This Corporation shall have two Directors initially. The number of Directors may be either increased or diminished from time to time by the By-laws, but shall never be less than two (2).

ARTICLE VII - INITIAL DIRECTORS

ARTICLE IX - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for money or any property or services of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the prices and on the terms at which it is offered to others.

ARTICLE X - VOTING RIGHTS

The shareholders of this corporation shall be allowed to vote their shares cumulatively so as to give one candidate as many votes as the number of directors to be elected multiplied by the number of his shares, to distribute them among as many candidates as he may wish. Notice must be given by any shareholder to the President or a Vice-President of said Corporation not less than

wenty-four (24) hours prior to the time set for the holding of a shareholders meeting for the election of directors that said shareholder intends to cumulate his vote at said election.




