ARTICLES OF INCORPORATION  
OF  
BLADERUNNER IN-LINE SKATING SCHOOL, INC.

ARTICLE ONE

The name of the corporation is Bladerunner In-Line Skating School, Inc. The principle address and mailing address of the corporation is 200 Windward Passage, Clearwater, FL 34630.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporation may be incorporated under the Florida Corporation Act. The primary purpose of the corporation is a school to teach rollerblading and hockey.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is 7,500 of the par value of One Dollar (\$1.00) each.
