Enclosed are Articles of Amendment to the Articles of Incorporation of Coastal Construction Group, Inc., for the purpose of changing its name to Coastal Disaster Response, Inc., and copies of the Articles of Amendment to the Articles of Incorporation for Coastal Disaster Response, Inc. for the purpose of changing its name to Coastal Construction Group, Inc.

As you can see, the same individual is president of both of these corporations. Originally, there was a corporation known as Coastal General Contractors, Inc. and the name of that corporation was changed to Coastal Disaster Response, Inc. However, this change was an error. Actually, the name Coastal General Contractors, Inc. was supposed to be changed to Coastal Construction Group, Inc., but when it was changed to Coastal Disaster Response, Inc., a new corporation known as Coastal Construction Group, Inc. was formed.

Due to some confusion with federal taxpayer identification numbers and federal income tax returns, the easiest, most realistic way of handling this matter is for the two corporations to amend their respective articles to change the name to the other corporation's name.

I contacted your office by telephone and they suggested sending these two articles of amendment to the articles of incorporation in together, with this letter of explanation, along with the fees involved for these matters. As such, we have enclosed our check in the amount of \$70.00 to cover the cost of two articles of amendment to the articles of incorporation.

Pursuant to the provisions of Section 607.1003 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the Corporation is COASTAL CONSTRUCTION GROUP, INC.

2. The following amendment to the Articles of Incorporation was adopted by the Shareholders of the Corporation on the 14th day of October, 1997 in the manner prescribed by the Florida Business Corporation Act:

Article I, titled "Name," is hereby amended to read as follows:

Article I

Name

The name of the Corporation is COASTAL DISASTER RESPONSE, INC.

3. The shares of the Corporation issued and outstanding at the time of adoption was One hundred (100) shares and the number of shares entitled to vote thereon was One hundred (100).

4. The number of shares voted in favor of such amendment was One hundred (100) shares and the number of shares voted against such amendment was zero (0).

5. The number of votes cast by the Shareholders of the Corporation in favor of the foregoing Amendment to the Articles of Incorporation was sufficient for approval.

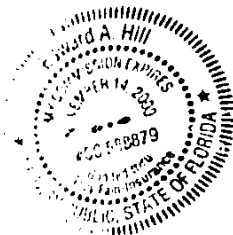
