I, the undersigned, hereby make, subscribe and acknowledge this Certificate for the purpose of becoming a Corporation under the Laws of the State of Florida.

The name and address of the person signing these Articles is Jesus Muia whose address is 15288 SW 169th Lane, Miami Florida 33187.


ARTICLE VIII - INDEMNIFICATION



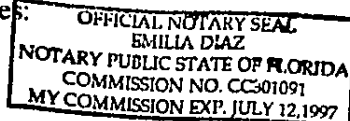
