ARTICLE I - NAME

The name of this corporation is SPM COMMUNICATIONS, INC., with its principal office and address being located at 5590 N.W. 38th Terrace, Coconut Creek, FL 33073 and its mailing address being 5590 N.W. 38th Terrace, Coconut Creek, FL 33073.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business. The corporation will also operate its own advertising agency.

ARTICLE IV - CAPITAL STOCK

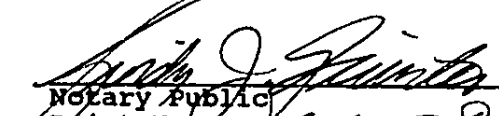
