ARTICLES OF INCORPORATION

CANVAS AUTHORITY, INC.

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

- 1. NAME. The name of the corporation is CANVAS AUTHORITY, INC.
- 2. TERM. The corporation shall exist perpetually. Corporate existence shall begin when there articles are filed with the Department of State.
