of

ARTICLE I - NAME

The name of the corporation is ----- VANCE'S AUTO REPAIR INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

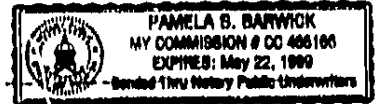
