The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

FIRST: The name of the corporation is: GBP Holdings Corp.

SECOND: The street address of the initial principal office and the mailing address of the corporation is: 37 West Broad Street, 5th Floor, Columbus, Ohio 43215.

THIRD: The duration of the corporation is perpetual.

FOURTH: The general purpose for which the corporation is organized is to engage in and transact any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

FIFTH: The aggregate number of shares the corporation is authorized to issue is four hundred shares, all of which shall be common shares. Such shares shall be of a single class and shall have \$.10 par value.

SIXTH: The street address of the initial registered office of the corporation is c/o C T Corporation System, 1200 South Pine Island Road, City of Plantation, Florida 33324, and the name of its initial registered agent at such address is C T Corporation System.
