I, the undersigned natural person of the age of twenty-one years or more, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of Florida.

ARTICLE I.

The name of the corporation is Vision Interactive, Inc., whose principal office is located at 3932 RCA Boulevard, Suite 3209, Palm Beach Gardens, Palm Beach County, Florida 33410.

ARTICLE II.

The period of duration of the corporation is perpetual unless dissolved according to Florida law.

ARTICLE III.

The purpose for which the corporation is organized is to engage in multimedia presentations or any other business or any other act or activities for which corporations may be organized under the General Statutes of the State of Florida.

ARTICLE IV.

The corporation shall have the authority to issue 10,000 (ten thousand) shares of common stock with a par value of \$1.00 (one dollar).

ARTICLE V.

The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is \$100.00 (one hundred dollars) in cash or property of equivalent value.

ARTICLE VI.


