The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE

AF

The name of the corporation is OOPSI, INCORPORATED, OF SARASOTA

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The corporation is organized to engage in the business of real property title examinations, to transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act and to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR

The aggregate number of shares which the corporation is authorized to issue is 100 shares of common stock. They shall have a par value of \$1.00 per share.

ARTICLE FIVE

The street address of the initial registered office of the corporation is 129 North Pineapple, Sarasota, Florida 34236, and the name of its initial registered agent at such address is Dawn Faynor.

ARTICLE SIX

The corporation shall have no Board of Directors, it shall be managed by its shareholders.

ARTICLE SEVEN

ARTICLE EIGHT

The shareholders shall elect within the statutory time to be a Subchapter S corporation and stock shall be issued and transferred to natural persons, estates or a trust described by statute defining a small business corporation.
