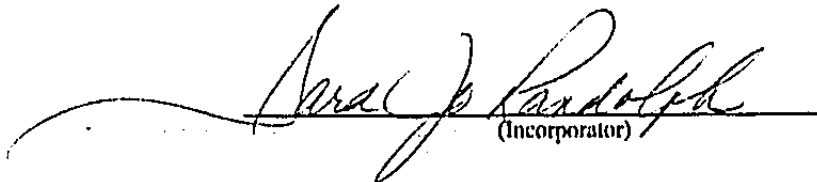
EIGHTH
INDEMNITY

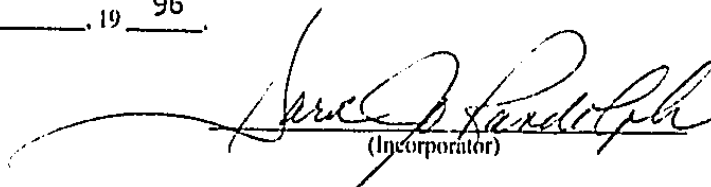
