ARTICLE I. NAME

The name of this Corporation shall be MAGIC WORLD INTERNET, SERVICES, INC.

ARTICLE II.

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State of Florida.

ARTICLE III.

This Corporation was organized for the purpose of transacting any or all lawful business for which Corporations may be incorporated, under Chapter 607 Florida Statutes, as now exists or may after be amended.

ARTICLE IV.

This Corporation is authorized to issue 500 shares of stock at One Dollar (\$1.00) par value common stock which shall be designated as Common Shares.


ARTICLE IX. - INDEMNIFICATION.


The Corporation shall indemnify any officer or Director or any former Officer or Director to the full extent permitted by law.


