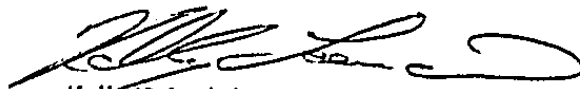

**Articles of Incorporation
of**

Kelly H. Leaird D.M.D., P.A.

The specific nature of this professional association will be the private practice of General Dentistry as governed by the Florida Dental Board and the Department of Professional Regulation.

The undersigned, acting as the incorporators of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby form a corporation for profit under the laws of the State of Florida and adopt the following Articles of Incorporation for such Corporation:

Article I - Name of Corporation

The name of this Corporation shall be Kelly H. Leaird D.M.D., P.A.

Article II - Term of Existence

This corporation shall exist perpetually, commencing on the date these Articles are filed with the Secretary of State for the State of Florida.

Article III - Principle Office

The principle office of this Corporation shall be located at 8585 S.W. SR 200 Suite 10 Ocala, Fl 34481

Article IV - Capital Stock

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is Ten (10) shares of common stock having a par value of one dollar (\$1) per share.

Article VI - Initial Registered Office and Registered Agent

The initial street address of the registered office of this Corporation in the State of Florida will be 8585 S.W. SR 200 Suite 10 Ocala, Fl 34481. 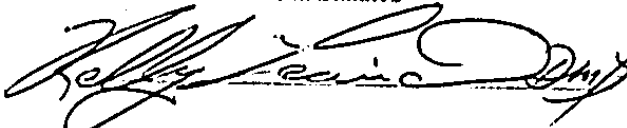
Article IX - Indemnification
