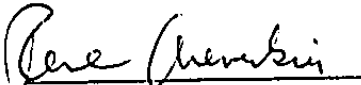
**ARTICLES OF INCORPORATION

DESIGN IMPORTS INC.**

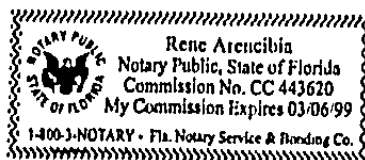
- FIRST:** The name of this corporation is **DESIGN IMPORTS INC.**
