

ARTICLES OF INCORPORATION

OF

COUNTRYWIDE APPRAISAL SERVICES, Inc.

The undersigned, desiring to form a corporation in accordance with Chapter 607 of the Florida General Corporation Act, adopt the following Articles of COUNTRYWIDE APPRAISAL SERVICES, Inc.

ARTICLE ONE

NAME

1.01 The name of the Corporation shall be COUNTRYWIDE APPRAISAL SERVICES, INC.

ARTICLE TWO

REGISTERED OFFICE AND AGENT

2.01 The location and address of the Corporation's principal office in Florida is 1521 Oakfield Drive, Brandon, Fl. 33511. The initial registered agent at the registered office is Frank A. Diaz 213 Morrison Road, Brandon, Florida 33511.

ARTICLE THREE

PURPOSE

3.01 The Corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

8.01 The amount of capital with which the Corporation shall begin business is Five Hundred Dollars (\$500.00).


ARTICLE NINE

No shareholder, notwithstanding that he or she may have voted against the amendment or may have objected in writing, shall be entitled to payment of the fair cash value of his or her shares or any other rights of a dissenting shareholder.




