To Whom It May Concern:

I phoned your office a couple of days ago and spoke to one of your agents in your "Corporate Renewals" department. I explained my problem/situation to the nice gentleman, who instructed me to put everything in a letter the best I could and send it to your office.

It is kind of a long and strung-out situation, but the agent assured me that if I would send this written letter, along with my renewal fee, everything would be handled and straightened out for me.

So; here goes:

In early 2000, I bought a corporation called Florida Job Link Corp., Corp. #59\$3379603, from a Mr. Jeff Wells and his wife, Anne. The small part-time business associated with this corporation deals with employment web sites, etc. that are specific to Florida. Mr. Wells was moving, due to a job transfer, to California. Naturally, it was going to be impossible for him to actively "work" the Florida business like he previously did while actually residing in Florida. The Wells were our friends and we bought the business.

He filed the 1999 annual report. In May/June of 2000, he filed the new annual report as a favor for me, as I did not know how to handle these things.

He sent in the renewal fee to your office with the report - and he tried to fill in the form so as to add me and my husband as the new officers and directors, replacing he and his wife. His check was cashed for the renewal, but your office sent him a letter back stating that he had filled out the form in an improper way, with regard to changing the directors/officers. He forwarded the letter to me to see. Apparently, the "new registered agent", (which was supposed to be me now), was supposed to have signed the form. But he signed his own name in that spot. (He was the "old" registered agent). So the "change" did not "stick".

I have filled out the new report in the manner, that, by speaking with your agent in Renewals, I was supposed to have done last year.

I now know how to keep the reports current and plan to attend a small business workshop next month offered by the University of South Florida.

Please assist me with this report, albeit late.
