ARTICLES OF INCORPORATION

OF

RIGHT TO BEAR ARMS, INC.

THE UNDERSIGNED SUBSCRIBERS TO THESE ARTICLES OF INCORPORATION,
EACH A NATURAL PERSON, COMPETENT TO CONTRACT, HEREBY ASSOCIATE THEMSELVES TOGETHER, TO FORM A CORPORATION FOR PROFIT, UNDER THE LAWS OF
THE STATE OF FLORIDA.

ARTICLE I

THE CORPORATION WILL BE NAMED RIGHT TO BEAR ARMS, INC., WHICH HAS BOTH ITS PRINCIPAL AND MAILING ADDRESSES LOCATED AT 827 SEMINOLE BLVD, TARPON SPRINGS, FL 34689.

ARTICLE II
