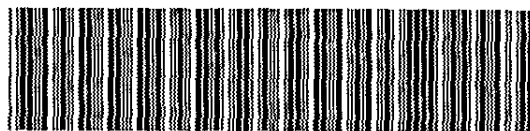



**SEVENTH:** The dissolution was authorized on December 1, 2002 and is effective on December 1, 2002.


