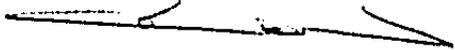

The undersigned subscribers to these Articles of Incorporation, a natural person competent to contract, heroby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

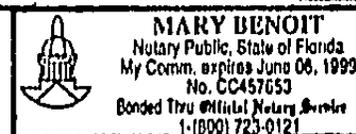
