ARTICLES OF INCORPORATION GOLF AND LAND SALES CORPORATION OF SOUTH FLORIDA

Constance L. Rao, the undersigned hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a corporation under the laws of the State of Florida.
