THE UNDERSIGNED SUBSCRIBERS to these Articles of Incorporation, natural persons competent to contract, hereby form a Corporation under the laws of the State of Florida.

ARTICLE I

Name

The name of the Corporation shall be: Demo-Mania Enterprises, Inc.

ARTICLE II

Nature of the Business

The general character or nature of the business to be transacted by this Corporation is as follows:

To engage primarily in the business of producing, distributing and promoting musical works from varied artist(s), to provide administrative support services to varied artist(s) and to own and operate any other business authorized under the laws of the State of Florida.

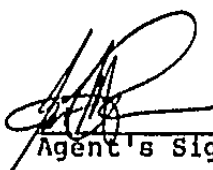

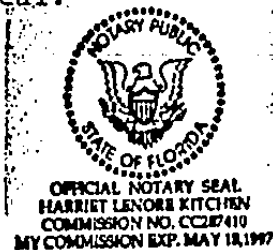

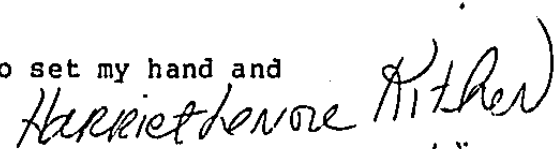
