# ARTICLES OF INCORPORATION OF D & J RACING, INC.

ARTICLE I - NAME

SECRETALL STATE TALLAHASSEE, FLORIDA

The name of this corporation is D & J RACING, INC.

The principal address of said corporation is 442 SW 54th Court, Ocala, FL 34474.

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence.

#### **ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

#### ARTICLE IV - CAPITAL STOCK

The Section is intended to expand the ability of the corporation to conduct business with interested parties and shall not be construed to invalidate any contract of other transaction that would otherwise be valid under the common and statutory law applicable to it.
