## ARTICLES OF INCORPORATION OF TITAN TANK COMPANY, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I

May 4,1996

#### Corporate Name and Principal Office

The name of this corporation is TITAN TANK COMPANY, INC. and its principal office is located at 11710-A Highway 301 North, Thonotosassa, Florida 33592 and its mailing address is P.O. Box 290676, Tampa, Florida 33687.

#### ARTICLE II

#### Commencement of Corporate Existence

The corporation shall come into existence on the date of subscription and acknowledgment of the Articles of Incorporation.

#### General Nature of Business
