**ARTICLE I - NAME**

The name of this corporation is **COBRA INVESTMENTS, INC.**

**ARTICLE II - PURPOSES**

This corporation is organized for the purposes of transacting any or all lawful business pursuant to the provisions of Chapter 607, Florida Statutes.

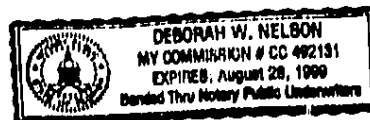
