The undersigned, in order to form a corporation for the purposes hereinafter stated, by and under the provisions of the statutes of the State of Florida, do hereby subscribe to these articles of Incorporation.

Articles I - NAME

ARTICLES II - DURATION

This corporation shall have perpetual existence. The corporation existence commences at the date of the execution **21ST** day of **MAY, 1996**

ARTICLES III - PURPOSE

This corporation is organized for the following purposes:


