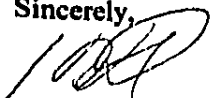

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation shall be:

**CAN DO IT ALL, INC.**

The address of the principal office of this Corporation shall be 6811 S.W. 9th Street, Pembroke Pines, Florida 33023, and the mailing address of the Corporation shall be the same.

**ARTICLE II**

The period of duration of the corporation shall be perpetual.

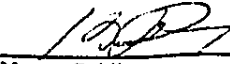
