

following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is **TEMPERATURE CONTROL, REFRIGERATION & AIR CONDITIONING, INC.**

ARTICLE II. DURATION

The term of existence of the corporation is perpetual.

ARTICLE III. PURPOSE


