

ARTICLES OF INCORPORATION OF MAPLE LEAF ADVISORS, INC.



The undersigned Incorporator, who is the subscriber to these Articles of Incorporation, in order to effect a duly incorporated Florida corporation, competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME AND ADDRESS: The name of this corporation is MAPLE LEAF ADVISORS, INC.

ARTICLEII

NATURE OF BUSINESS: The corporation may engage in any activity or business permitted under the laws of the United States and of this State. The purpose of the corporation is to provide investment advisory services.
