**ARTICLE I--NAME**

The name of this corporation is JUNE COLBURN DESIGNS II, INC.

**ARTICLE II--DURATION**

This corporation shall exist perpetually.

**ARTICLE III--PURPOSE**

This corporation is organized for the purpose of any and all lawful business which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE IV--POWERS**


