The undersigned incorporator, being competent to contract, subscribes to these Articles of Incorporation to form a corporation for profit under the laws of the state of Florida,

ARTICLE I - Name

The name of this corporation shall be:

NELSON'S BAIL BOND AGENCY, INC.

ARTICLE II - Principal Office and Mailing Address

The principal office of the corporation is located at 503 WEST CHURCH STREET, ORLANDO, FLORIDA 32805, and the mailing address of the corporation is 503 WEST CHURCH STREET, ORLANDO, FLORIDA 32805.

ARTICLE III - Initial Registered Office and Agent

The name of the initial registered agent of this corporation is Robert C. Wilkins, Jr., and the street address of the initial registered office of this corporation is 230 LOOKOUT PLACE, MAITLAND, FLORIDA 32751.

ARTICLE IV - Business and Activities

This corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the state of Florida.

ARTICLE V - Capital Stock

The authorized capital stock of this corporation and the maximum number of shares of stock that this corporation is authorized to issue and have outstanding as any one time is 10,000 shares of common stock having a par value of \$1,00 per share.
