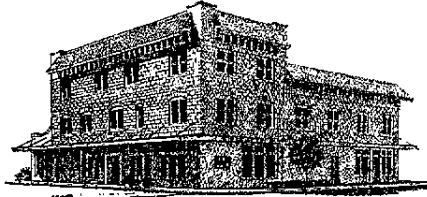

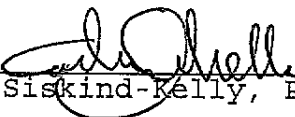
1. The name of the Corporation is Three K Marketing, Inc., a Florida corporation.

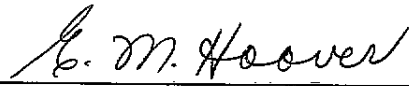
