ARTICLES OF INCORPORATION

OF

BOMAR CREDIT CORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of this corporation is BOMAR CREDIT CORPORATION and its principal office is located at 3184 Highway 98 E., #315A, Destin, Florida 32541, and its mailing address is the same.

ARTICLE II

DURATION

This corporation shall exist perpetually, commencing upon the date of subscription and acknowledgement of these Articles of Incorporation.
