ARTICLES OF INCORPORATION OF CLICK OK, INC.

The undersigned, acting as sole incorporator of a corporation under the Florkin Business Corporation

Act, adopts the following Articles of Incorporation for such corporation:

EIRST: The name of the corporation that satisfies the requirements of Section 607.0401 is:

CLICK OK, INC.

SECOND: The address of the principal office and the mailing address of the corporation is: e/o Henry L. Laws, II, Department of Surgical Education, 1600 Carraway Boulevard, 4th Floor, Birmingham, Alabama 35234.

THIRD: The period of its duration is perpetual.

FOURTH: The purposes for which the corporation is organized are as follows:

- (a) To engage in the business of conducting a computer learning and training facility.
- (b) To render to others, and to engage in the business of rendering to others, consulting, advisory, administrative, industrial engineering, accounting, bookkeeping and other services of every nature, kind and character, which a corporation may legally render;

- (f) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, associations, partnerships, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;

- To lend money, invest and reinvest its funds and take and hold real (g) and personal property as security for the payment of funds so loaned or invested; and
- To transact any or all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

FIFTH: The aggregate number of shares which the corporation shall have authority to issue is Five Thousand(5,000) shares of common stock of the par value of One Dollar (\$1.00) per share.
