

ARTICLES OF INCORPORATION

of

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Robert Parker Construction, Inc.




