Corporate Name**

The name of this corporation is: VUSAR, Inc.,

**ARTICLE II  
Nature Of Business And Powers**

The general nature of the business to be transacted by VUSAR, Inc. is to engage in any and all business permitted under the laws of the State of Florida.


